REASONS/EXPLANATION/NOTES:

First item in the table: The city proposed a joint project to the SRA regarding upgrading the WTP's intake facility. At the time of budget approval, the SRA indicated that this would probably be funded; however, later in 2023 they determined they would not be able to fund/approve that project. The city had allocated \$60,000 dollars to fund half the project, without the other half of the funding not being available the city manager is requesting to postpone this project and re-allocate the resource to cover the other unfunded liabilities listed above.
